## Newsletter

The Bass Rock, Bell Rock and R.N.L.I. Races were well supported by the Club and our International Fair Isle Race proved successful and continues to make our name known among an ever increasing circle of yachtsmen.

## Rescue Boat

As you will all know the Rescue Boat has now been completed and ready for the water. There has been much admiration for Bob Sandison's craftsmanship and I am sure you will all join in offering him our sincere thanks.

## Boatyards

It has been arranged that our boats will be lifted out on Saturday, 18th October commencing 8 a.m. It is requested that all dinghies which are not over-wintering be removed from the yards by Sunday, 5th October, 1975.

During this season there has been an increased incidence of vandalism and members are requested to be security conscious. Gates are being left open and it is the responsibility of anyone leaving the yard to ensure that if no other members are present in the yard that the gates are securely padlocked. Inconvenience has been caused to members through a padlock having to be changed mid-season, this was caused through the forcing of our padlock and the subsequent wait until such time as a padlock with a similar turret could be obtained. The inconvenience caused to members is very much regretted.

Members are again reminded that permission should be obtained before any outside company or contractor moves boats into or out of our yards or mooring area. It is also requested that we be advised if any brokers etc. are selling boats which are situate in our yards or mooring area.

## Membership

Membership Application Forms are available on written application to the Club Secretary. Associate Membership is at its numerical limit and no applications are at present being accepted for this class of membership. It should be noted that while membership application is pending such persons can only be introduced not exceeding two times in any one month as a guest.

## Clubhouse

The Club Council have been concerned at the distinct lack of respect for the Club and its property.
